TOUR DETAILS, TERMS, AND CONDITIONS

MS&T14 Registrations: All tour registrants **must register and attend** MS&T14. Registration, travel and hotel reservations for MS&T14 are the responsibility of the individual student.

Tour Boarding and Departure: Tour departs from the David L. Lawrence Convention Center. Tour participants must meet at 12:00 p.m. to board the bus. Boarding location to be determined. The bus departs **promptly** at 12:30 p.m. The bus will arrive at PGW between 1:00 and 1:15 p.m., and the return bus to the convention center will be back no later than 5 p.m.

Dress code: Please keep in mind that you are entering a professional work environment and appropriate attire is required. Guests should wear comfortable, flat, fully-enclosed shoes (no high-heels, sandals, flip-flops, slides, mules, Crocs, etc.) during the tour. Long pants or jeans are also required. PGW is a multi-level manufacturing facility, so you will need to be able to climb steps.

Cameras and Cell Phones: Cameras are off limits upon entering the building. Cell phone use is not permitted in the facility while the tour is taking place.
