TOUR DETAILS, TERMS, AND CONDITIONS

MS&T16 Registrations: All tour registrants **must register and attend** MS&T16. Registration, travel and hotel reservations for MS&T16 are the responsibility of the individual student.

Tour Boarding and Departure: Tour departs from the Salt Palace Convention Center. Tour participants must meet at 12:15 p.m. to check-in and board the bus. Boarding location to be determined. Lunch will NOT be provided prior to boarding the bus. It is recommended that attendees pick up a portable lunch prior to arriving for check-in and boarding the bus. The bus departs **promptly** at 12:35 p.m. The bus will arrive at Amedica Corporation at 1:00 p.m., and the return bus to the convention center will be back no later than 5 p.m.

Dress code: Please keep in mind that you are entering a professional work environment and appropriate business casual attire is required. You will be touring a plant; therefore, attendees should wear comfortable, flat, fully-enclosed shoes (no high-heels, sandals, flip-flops, slides, mules, Crocs, etc.) during the tour. Long pants are also recommended. No shorts please.

Cameras and Cell Phones: Cameras are off limits upon entering the building. Cell phone use is not permitted in the facility while the tour is taking place.
