Health and Safety at EMA 2022

Your health and safety are important to us. The American Ceramic Society, working in partnership with the DoubleTree by Hilton Hotel Orlando at SeaWorld, are complying with guidance from the Centers for Disease Control and relevant state and local authorities in an effort to provide a safe and healthy environment for EMA 2022 attendees during the ongoing COVID-19 pandemic.

However, COVID-19 is an extremely contagious disease and it is not possible to eliminate the risk of spreading or contracting COVID-19. An inherent risk of exposure to COVID-19 exists in any public place where people are present, and efforts to mitigate the risk of exposure to COVID-19 may not be sufficient to prevent spreading or contracting COVID-19.

The American Ceramic Society asks you NOT attend EMA 2022 if any of the following apply:

- If you have received a positive COVID-19 test within 14 days of EMA 2022.
- If you have experienced symptoms of COVID-19 within 14 days of EMA 2022. COVID-19 symptoms include cough, shortness of breath, fever, chills, headache, muscle pain, sore throat, and loss of taste or smell.
- If you have been directed by Public Health to self-isolate within 14 days of EMA 2022.
- If you have knowingly come into contact with a confirmed or suspected COVID-19 case within 14 days of EMA 2022.
- If you are currently caring for a family member or any person who is sick or exhibiting COVID-19 symptoms or have cared for anyone who is sick or exhibiting COVID-19 symptoms within 14 days of EMA 2022.
