The most presentation country was Korea with 400 presentations, followed by Japan, 118 presentations, China, 39, Germany 28, and USA 25 presentations. The largest number of participants was 434 from Korea, followed by 107 participants from Japan, 39 from China, 26 from USA, and 19 from Germany.

Agenda 4 Update on ICC9

Prof. Zbigniew Pedzich provided an update on ICC9. The ICC9 will be held

together with the 17th Conference & Exhibition of the European Ceramic Society (ECerS XVII) and 18th Electroceramics conference (Electroceramics XVIII) at the ICE Krakow Congress Centre on July 10-14, 2022.

Agenda 5 Update on ICC10

Ms. Andrea Ross provided an update on ICC10. The ICC10 will be held on July 14-19, 2024 at Hotel Bonaventure, Montreal, Quebec, Canada. The ICC10 President is Edgar Lara-Curzio. More than 650 attendees are expected, which include 8 plenary speakers, 84 invited talks, 160 contributed talks, and 200 posters.

Agenda 6 ICC11 Proposal

The Ceramic Society of Japan, Dr. Kazumi Kato as conference chair, proposed ICC11. The ICC11 will be held on September 6 to 11, 2026 in Sapporo Japan. There was no objection to the proposal. The proposal from the Ceramic Society of Japan was unanimously approved.
